

**ARTICLE XXXII**  
**BOARD**

**§ 180.110. BOARD continued; membership.**

The BOROUGH COUNCIL shall continue to appoint a Zoning Hearing BOARD consisting of three (3) members who are residents of the BOROUGH. The BOARD appointed and serving shall continue without interruption. Membership of the BOARD and terms of office shall be as mandated by Article IX, § 903, of the Municipalities Planning Code.<sup>1</sup>

**§ 180.111. Removal of members.**

The members of the BOARD shall be removable for cause in accordance with Article IX, § 905, of the Municipalities Planning Code.<sup>2</sup>

**§ 180.112. Organization.**

The BOARD shall organize in accord with Article IX, § 906, of the Municipalities Planning Code.<sup>3</sup>

**§ 180.113. Adoption of rules and regulations.**

The BOARD shall adopt its rules and regulations in accordance with the provisions of the Municipalities Planning Code.<sup>4</sup>

**§ 180.114. Meetings and hearings.**

The meetings and hearings of the BOARD shall be in accordance with its own rules and regulations, subject to the requirements of Article IX, § 908, of the Municipalities Planning Code.<sup>5</sup>

**§ 180.115. Powers, duties and functions.**

The BOARD shall have the powers and duties and functions as set out in the Municipalities Planning Code and particularly in Article IX, §§ 909, 910, 912 and 913.<sup>6</sup>

**§ 180.116. Expenditures.**

In exercising the above-mentioned powers and functions, the BOARD may make expenditures for services within the limits of funds appropriated by COUNCIL in accordance with Article IX, § 907, of the Municipalities Planning Code.<sup>7</sup>

**§ 180.117. Appeals.**

Appeals to the BOARD may be taken by any PERSON aggrieved within the time limits and under the conditions set out in Article IX, § 915, of the Municipalities Planning Code.<sup>8</sup>

**§ 180.118. Effect of appeal.**

An appeal shall stay all proceedings in accordance with Article IX, § 916, of the Municipalities Planning Code.<sup>9</sup>
