# ARTICLE III Parking Regulations

## § 171.22. Parking without lights.

The boundary limits of the BOROUGH are hereby established as a zone in which motor vehicles may remain standing without lights, and all STREETS and HIGHWAYS within such boundary limits except State Route 51, also known as "Clairton Boulevard" and "Saw Mill Run Boulevard," are hereby designated as HIGHWAYS where motor vehicles may remain standing without lights.

### § 171.23. Parking within marked spaces.

Wherever a space shall be marked off on any STREET or HIGHWAY for the parking of an individual vehicle, it shall be unlawful for any PERSON, firm or corporation, whether principal or agent, not to park any vehicle within the lines bounding such space.

## § 171.24. Angle parking.

- 171.24.1. Only angle parking shall be permitted on the portions of the HIGHWAYS listed on Schedule XV (§ 171.50) attached hereto and incorporated herein.
- 171.24.2. On all HIGHWAYS or portions thereof where angle parking is now or shall hereafter be authorized, all vehicles parked thereon shall be parked with the front thereof nearest the curb.

# § 171.25. No-stopping areas.

In the areas described on Schedule XV (§ 171.51) attached hereto and incorporated herein, no stopping shall be permitted at any time except at official traffic signals, provided that vehicles licensed for public transportation shall be permitted to stop at authorized stations.

#### § 171.26. No-parking areas.

- 171.26.1 Parking is hereby prohibited on the HIGHWAYS listed on Schedule XVI (§ 171.52) attached hereto and incorporated at all times on the sides of the HIGHWAY in the locations indicated on Schedule XVI. [Added by Ord. No. 1077 on June 3, 2015]
- 171.26.2 Parking is hereby prohibited on all DEAD ENDS and CUL-DE-SACS, with the exception of any CUL-DE-SACS identified in Schedule XVII: Restricted Parking (§ 171.53). For any CUL-DE-SACS identified in § 171.53, parking is restricted only as described in § 171.53, and is allowed at all other times. [Added by Ord. No. 1077 on June 3, 2015]

### § 171.27. Restricted parking.

- 171.27.1. Parking prohibited during certain hours. No PERSON shall park a vehicle between the hours specified on Schedule XVII (§ 171.53) attached hereto and incorporated herein of any day upon any of the HIGHWAYS or parts of HIGHWAYS listed on said Schedule XVII.
- 171.2.2. Time-limit parking. No PERSON shall park a vehicle for longer than the time established on Schedule XVII attached hereto and incorporated herein at any time between the hours indicated of any day (except Sundays and holidays) upon any of the HIGHWAYS or parts of HIGHWAYS described on Schedule XVII.
- 171.27.3. The Chief of Police shall develop and publish a policy to be approved by resolution of the COUNCIL of the BOROUGH dealing with the enforcement of all-night STREET parking on those STREETS listed in Schedule XVIII (§ 171.53). [Added 12-20-89 by Ord. No. 748]

# § 171.28. Special purpose parking zones.

- 171.28.1. The zones listed on Schedule XVIII (§ 171.54) attached hereto and incorporated herein are hereby established as special purpose parking zones, and it shall be unlawful for any PERSON to park any vehicle or tractor or to allow the same to remain parked in any such zone except as specifically provided for such zone.
- 171.28.2. The penalties for violation of special purpose parking zones shall be those prescribed by the VEHICLE CODE of 1976, as amended, except as otherwise prescribed on Schedule XVIII.
- 171.28.3. At the request, in writing, of any handicapped PERSON or severely disabled veteran qualifying for a handicapped plate or placard pursuant to 75 Pa.C.S.A. § 1338 or 1342, and after review and recommendation by the Traffic Officer of the Police Department and the Chief of Police, COUNCIL may authorize the erection of a sign or signs indicating that a place in length not to exceed twenty (20) feet and as close as possible to the place of residence of the handicapped PERSON is reserved for a vehicle of the handicapped PERSON or severely disabled veteran or a vehicle which is parked in the act of providing transportation for the handicapped PERSON or severely disabled veteran and that no parking is allowed there by others and that any unauthorized PERSON parking there shall be subject to the maximum penalties provided by law. The authorization granted shall expire when the handicapped PERSON or severely disabled veteran ceases to reside in said residence. [Added 8-2-89 by Ord. No. 745]
  - 171.28.3 At the request, in writing of any handicapped PERSON or severely disabled veteran qualifying for a handicapped plate or placard pursuant to 75

Pa.C.S.A. § 1338 or 1342, and after review and recommendation by the Traffic Officer of the Police Department and the Chief of Police, COUNCIL may authorize the erection of a sign or signs indicating that a place in length not to exceed twenty (20) feet and as close as possible to the place of residence of the handicapped PERSON is reserved for a vehicle of the handicapped PERSON or severely disabled veteran or a vehicle which is parked in the act of providing transportation for the handicapped PERSON or severely disabled veteran and that no parking is allowed there by others and that any unauthorized PERSON parking there shall be subject to the maximum penalties provided by law. Any such parking space shall be placed on a portion of the STREET where parking is permitted for non-handicapped individuals, unless COUNCIL determines that the parking space must be placed in no-parking zone because:

- Due to the nature of the resident's disability and issues regarding access to his or her residence, the handicapped space must be placed in a no-parking zone and;
- 2. The placement of the handicapped space in a no-parking zone will not fundamentally alter safety, traffic, parking or any other service, program or activity within the Borough.

In the event a handicapped parking space under this section is placed on a portion of the street where parking is permitted for non-handicapped individuals, the handicapped parking space shall be subject to the same time limitations applicable to parking spaces for non-handicapped individuals. With regard to a handicapped parking space approved by COUNCIL to be located in a no-parking zone, there shall be no parking between the house of two a.m. and six a.m. and a two-hour time limit for parking in the space during all other times. The parking restrictions under this section shall be indicated on any signage marking the parking space as reserved. The restriction on parking between the hours of two a.m. and six a.m. and the restriction of parking to two hours at all other times, shall not apply to any parking space under this section approved by COUNCIL prior to the effective date of these restrictions. The authorization granted shall expire when the handicapped PERSON or severely disabled veteran ceases to reside in said residence [ Added 12-21-16 by Ord. No. 1092]

## § 171.29. Posting of signs.

All parking restrictions as set forth in Article III of this Part 1, except § 171.23, shall be subject to the posting of proper signs as required by the VEHICLE CODE of 1976, as amended.<sup>2</sup>
